PURSUANT to the Sale and Supply of Alcohol Act 2012 (the Act), CENTRAL N.I.  - grape wine that complies with the appropriate New Zealand food standard for grape wine; or
 - a food flavouring, prepared for culinary purposes, that is unsuitable for drinking undiluted.
- Alcohol may be sold only on the following days and during the following hours: (c)

7.00 am to 10.00 pm Monday to Sunday

The premises is Undesignated (d)

- Only the area delineated on the plan submitted with the application dated 2 March 2017, is a permitted area for (e) the display and promotion of alcohol.
- Drinking water is to be freely available to customers, while alcohol is being supplied free as a sample. (f)
- A copy of this licence must be displayed at the principal entrance to the premises. The entrance from the (g) carpark is designated as the principal entrance.

DURATION

subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force-

- until the close of the period for which it is renewed; or
- if an application for the renewal of the licence is duly made before it would otherwise expire, until the close of the period of 3 years after the period for which it is renewed.
