Terms and conditions

1. Entry into this Gilmours Christmas promotion (**Promotion**) constitutes acceptance of these terms and conditions.

Promoter

2. The Promoter is Foodstuffs North Island Limited (**Promoter**), of 35 Landing Drive, Mangere, Auckland.

Participating stores

3. This Promotion is being run in all eight Gilmours stores in the North Island of New Zealand (**Participating Stores**).

Prize

4. There are 24 \$100 (including GST) Z Energy fuel vouchers to be won, with three winners per Participating Store (each, a **Prize**). The total prize pool is worth \$2,400 (including GST).

Promotion period

5. This Promotion commences at the start of trade on 17 November 2025 and ends close of trade 14 December 2025 (**Promotion Period**).

Method of entry

6. To enter and be eligible to win a Prize under this Promotion, Gilmours' account holders must purchase at least three of the participating Christmas feature products outlined in Schedule 1 (**Participating Products**) within one receipt/invoice at a Participating Store (online or in-store) during the Promotion Period (**Eligible Entry**). For the avoidance of doubt, the Participating Products are those set out in Schedule 1 and are also showcased on pages 3-7 of the BG06 Buyers Guide (excludes all alcohol).
7. Each Eligible Entry means one (1) entry into the draw. For every three Participating Products purchased in accordance with clause 6, you will receive an additional Eligible Entry.

For the avoidance of doubt, customers can receive unlimited entries into this Promotion by making multiple Eligible Entries, via multiple orders, so long as at least 3 Participating Products have been purchased within one receipt/invoice in accordance with clause 6. For example, a customer could purchase 3 Participating Products in one receipt/invoice in accordance with clause 6 and receive one Eligible Entry, and could receive one more Eligible Entry by purchasing 3 more Participating Products in another, separate invoice/receipt in accordance with clause 6.

How winners are selected

9. The Promoter will randomly select 24 winners (3 from each Participating Store) from all of Eligible Entries received from all Participating Stores by 21 December 2025. Each Eligible Entry will be assigned to the Participating Store from which the entry is made, and 3 winners will be randomly selected from each Participating Store.
10. The winners will be contacted using the contact information provided on their Gilmours account to provide the customer with the Prize.
11. The Promoter is not responsible if a winner has provided incorrect contact information, and any such winner will forfeit the Prize to the next eligible winner.
