

## **BG12 Samba Weber Go Anywhere BBQ Promotion via Gilmours February 2025**

### **Terms and conditions**

1. Entry into this Samba Weber Go Anywhere BBQ giveaway promotion (**Promotion**) constitutes acceptance of these terms and conditions and any other applicable terms and conditions.

### **Promoter**

2. The Promoter is Foodstuffs North Island Limited (**Promoter**), of 35 Landing Drive, Mangere, Auckland.

### **Participating Stores**

3. This Promotion is being offered at all Gilmours North Shore, Gilmours Mt Roskill, Gilmours Manukau, Gilmours Hamilton, Gilmours Tauranga, Gilmours Central, and Gilmours Wellington (**Participating Stores**).

### **Prize**

4. There is one (1) Weber Go Anywhere BBQ (**Prize**) valued at \$189 each including GST to be won per Participating Store under this Promotion. There are seven (7) Prizes to be won in total, one per Participating Store. The total prize pool is valued at \$1,323 including GST.

The Prize will be available for pick up only from the Participating Store where the winner made the Eligible Entry. If the winner is unable to collect the Prize from the relevant Participating Store, the

Prize will be forfeited, a further draw will be conducted, and the Prize allocated to a new winner.
