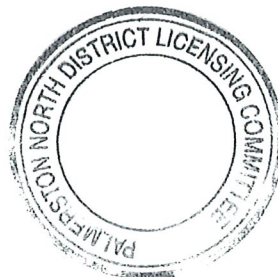
The conditions of the former licence shall continue to operate until a new licence is issued.

**DECISION**

This is an application by Gilmours Central Liquor Wholesalers Limited for an Order for Temporary Authority pursuant to section 136 of the Act in respect of Gilmour Central situated at 3-9 Jasper Place, Milton, Palmerston North.


The Committee notes that no objection has been received from the Licensing Inspector and the Police relating to the application. Accordingly, the Committee deals with the matter on the papers.

The Committee, based on the information provided in the report, dated 16 April 2025, by the Licensing Inspector and related documents, grants the applicant an Order for Temporary Authority authorising the sale and supply of alcohol for a period of three months from 22 April 2025 or until the application by Gilmour Central Liquor Wholesalers Limited for a Remote Off-Licence is determined, whichever is the earlier.

The licence may be issued immediately.

The applicant's attention is drawn to sections 56 and 57(1) of the Act obliging the holder of a Remote Off-Licence to ensure that for each principal entrance to the premises there is displayed at all times a sign attached to the inside or outside of the premises, so as to be easily read by people immediately outside the entrance, stating the ordinary hours of business during which the premises are open for the sale of alcohol.

**REPORT:** This application is complex and has come about for two reasons. Pomana Marsh will become the new owner of Gilmours Central Liquor Wholesalers Limited.

The current director, Peter Blackwell, is retiring. With Pomana Marsh having purchased the business, the change of ownership will take effect on May 4, 2025.

They require a Temporary Authority to allow them to continue trading under the current off-licence. The current base Off Licence expires on 19/04/2026.

The application was initially submitted under SP Wholesale LTD, which is owned by Pomana Marsh. However, after discussions with Foodstuffs, Gilmours Central Liquor Wholesalers Limited, and Pomana Marsh, it was decided that the best way forward would be for Pomana Marsh to apply for the Temporary Authority under Gilmours Central Liquor Wholesalers Limited.

The new remote off-licence application has been submitted to the Council. However, as the application will not be determined in time by the licensing committee, a Temporary Authority is needed for the new director to begin operating in time for the change of ownership.

Peter Blackwell, the current director, has submitted a letter to the Council permitting Pomana Marsh to oversee the applications relating to Gilmours Central Liquor Wholesalers Limited.

The applicant is a company with 1 director and 1 shareholder.

The certificate holding duty managers are Stephen John Anderson 39/CERT/124/2016, Stephen Marc Drummond 40/CERT/029/2024, Jiajia Huang 39/CERT/056/2024 – expiry 18/06/2025, Samantha Ann Judith Rae 39/CERT/116/2017, Neha Sharma 39/CERT/033/2023.

The building owner has provided written consent for alcohol to be sold and supplied at the premises.

The applicant has provided a signed Agreement for Sale and Purchase of a Business and assets.

The Police have no opposition to the application.

**CONCLUSION:**

As the Licensing Inspector for Palmerston North City Council, I have no opposition to the granting of this Order for Temporary Authority.
