## SALE AND SUPPLY OF ALCOHOL ACT 2012

### OFF-LICENCE

Sections 18 and 64, Sale and Supply of Alcohol Act 2012

**Section 40 of the Act applies to this licence.**

PURSUANT to the Sale and Supply of Alcohol Act 2012(the Act), **TAURANGA LIQUOR MERCHANTS LIMITED** (the licensee) is authorised to sell alcohol from (but not on) the premises situated at **31 TAURIKURA DRIVE, TAURIKO, TAURANGA 3171** and known as "**TAURANGA LIQUOR MERCHANTS (AKA GILMOURS TAURANGA)**", to deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

### CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold from the premises at any time on any day, and delivered somewhere else for consumption off the premises only on the following days and hours:

**Monday to Sunday from 08:00am to 08:00pm**

2. No alcohol is to be delivered from the premises on Good Friday, Easter Sunday or Christmas Day or before 1.00 pm on Anzac Day.
3. No alcohol is to be delivered to the buyer (or to any other person on the buyer's behalf) at any time after 11pm on any day and before 6am on the next day.
4. A properly appointed certificated or Acting or Temporary Manager must be on duty, at or nearby the point of sale, at all times when the premises are open for the sale and supply of alcohol.
5. The licensee must follow the procedures set out in Regulation 14 of the Sale and Supply of Alcohol Regulations 2013 to ensure that neither the purchaser nor the person to whom alcohol is delivered is a minor.
6. The licensee must display *on its website and in its catalogue and on every receipt issued for alcohol sold remotely*:
  - a. the licence holder's name and licence number;
  - b. the date on which the licence expires;
  - c. a legible image of the licence or a clearly identified link to such an image.

### THE LICENSED PREMISES

The premises, situated at 31 TAURIKURA DRIVE, TAURIKO, TAURANGA 3171, is more precisely identified as outlined in a plan date stamped as received by the Tauranga District Licensing Committee on 8 February 2019.

### DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force until the close of the period for which it is renewed.
