

BG01 Swift Master Class Be In To Win Promotion

Terms and conditions

1. Entry into this BG01 Swift Master Class Be In To Win promotion (**Promotion**) constitutes acceptance of these terms and conditions.

Promoter

2. The Promoter is Foodstuffs North Island Limited (**Promoter**), of 35 Landing Drive, Mangere, Auckland.

Participating stores

3. This Promotion is being run in all Gilmours stores in the North Island of New Zealand (**Participating Stores**).

Prize

4. There are six (6) prizes available to be won across all Participating Stores containing:
 - a. One (1) ticket to a Private Swift Pork Masterclass valued at \$200 hosted by Team BBQ War.
