

SEAFOOD SPLASH - Weekly Store Credit Prizes - BE IN TO WIN COMPETITON

Terms and conditions

1. Entry into this Gilmours Seafood Splash promotion (**Promotion**) constitutes acceptance of these terms and conditions.

Promoter

2. The Promoter is Foodstuffs North Island Limited (**Promoter**), of 35 Landing Drive, Mangere, Auckland.

Participating stores

3. This Promotion is being run in all eight Gilmours stores in the North Island of New Zealand (Participating Stores).

Prize

- 4. There are 32 prizes to be won, one winner per Participating Store for each week of the Promotion Period. Winners will receive either:
 - a. a \$100 (excluding GST) Gilmours store voucher for Cash'n Carry customers; or
 - b. a \$100 (excluding GST) Gilmours store credit for service delivery and online customers,

(each, a Prize). The total prize pool across all Participating Stores is \$3,200 (excluding GST).

Promotion period

5. This Promotion commences at the start of trade on 20th October 2025 (**Promotion Start Date**) and ends close of trade 16th November 2025 (**Promotion Period**).

Method of entry

- 6. To enter and be eligible to win a Prize under this Promotion, Gilmours' account holders must purchase at least one of the participating products listed at Schedule 1 (Participating Products) at a Participating Store (online or in-store) during the Promotion Period (Eligible Entry).
- 7. Each Eligible Entry means one (1) entry into the draw. You will receive an additional Eligible Entry for every Participating Product you purchase during the Promotion Period as part of an Eligible Entry. Customers' can make unlimited Eligible Entries during the Promotion Period

(either within one receipt/invoice or as part of a separate receipt/invoice). The prize pool you will be entered into will be determined in accordance with clause 8. See the table below as an example:

- 8. One winner will be drawn by the Promoter each week of the Promotion Period for each Participating Store, as part of 32 separate prize draws total. Each prize draw will be conducted by random electronic selection from all Eligible Entries received at the relevant Participating Store from start of business Monday to close of business Sunday from the week prior (Weekly Prize Pool). Winners will be drawn by the Promoter on the Monday following the last Sunday of each Weekly Prize Pool (Weekly Prize Draw). For example, the first Weekly Prize Draw conducted on 27/10/2025 will consist of all Eligible Entries received at the relevant Participating Store from the Promotion Start Date until close of trade on 26/10/2025. The next separate Weekly Prize Draw will be conducted on 3/11/2025 and will consist of all Eligible Entries received at the relevant Participating Store from 27/10/2025 until close of trade 02/11/2025. There will be 32 Weekly Prize Draws in total (1 per each Participating Store, for the 4-week Promotion Period).
- 9. The winner will be contacted to arrange delivery of the Prize, using the contact information provided on each winner's Gilmours account.
- 10. The Promoter is not responsible if a winner has provided incorrect contact information, and any such winner will forfeit the Prize to the next eligible winner.
- 11. Winners can only be awarded one Prize. If a winner is drawn for an additional Prize (including by winning a Prize during a previous Weekly Prize Draw), the Prize will be forfeited, a further draw will be conducted, and the Prize allocated to a new winner.
